The Provincial Government of Camarines Norte, invites bids for the following projects/contracts:

Bids received in excess of the ABC shall be automatically rejected at bid opening.

Bidders should have completed at least one (1) contract similar to the project. The description of an eligible bidder is contained in the bidding documents, particularly Clause 5 of the Instruction to Bidders. Provided, however, that Contractors under Small A and Small B categories without similar experience on the contract to be bid may be allowed to bid if the cost of such contract is not more than fifty percent (50%) of the Allowable Range of Contract Cost (ARCC) of their registration based on the guidelines as prescribed by the PCAB.

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Revised Implementing Rules and Regulations (RIRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stocks belonging to citizens of the Philippines.

Interested bidders may obtain further information and inspect the bidding documents at the address given below.

A complete set of bidding documents may be acquired by interested bidders on July 22 – August 11, 2015 at the BAC, Provincial Capitol, Daet, Camarines Norte and upon payment of a non-refundable fee to the Provincial Treasurer's Office for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of FIVE THOUSAND PESOS (P5,000.00).

The Provincial Government of Camarines Norte will hold a Pre-Bid Conference on July 29, 2015, 2:00 p.m. at the BAC Office, 2<sup>nd</sup> Floor, Provincial Capitol Bldg., Daet, Camarines Norte.

Bids must be delivered at the Bids and Awards Office, 2<sup>nd</sup> Floor Provincial Capitol Building, Daet, Camarines Norte on August 11, 2015 at 10:00a.m. to 1:30p.m. Opening of bids will be on August 11, 2015 at 2:00p.m.

All bids must be accompanied by a bid securing declaration and/or any of the acceptable forms and in the amount stated in ITB Clause 18.

Bids will be opened in the presence of the bidder's representatives who choose to attend at the address below. Late bids shall not be accepted.

The Provincial Government of Camarines Norte reserves the right to accept or reject any bid, to annul the bidding process and to reject any or all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
