The Provincial Government of Camarines Norte through its Bids and Awards Committee (BAC) invites suppliers/manufacturers/distributors and contractors to apply for eligibility and to bid for the following items:

Bids received in excess of the ABC shall be automatically rejected at bid opening.

Bidders should have "statement of all on-going and completed government and private contracts including those awarded, but not yet started (similar or not similar), (Sec. 23.1.a.111)".

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Revised Implementing Rules and Regulations (RIRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to **Filipino citizens/sole proprietorships, partnerships, or organizations** with at least sixty percent (60%) interest or outstanding capital stocks belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

A complete set of bidding documents may be acquired by interested bidders on January 26 – February 10, 2015 at the BAC, Provincial Capitol, Daet, Camarines Norte and upon payment of a non-refundable fee to the Provincial Treasurer's Office for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of FIVE THOUSAND PESOS (P5,000.00).


All bids must be accompanied by a Bid Securing Declaration and at least one (1) of the acceptable forms and in the amount stated in ITB Clause 18.

The Provincial Government of Camarines Norte will hold a Pre-Bid Conference on January 28, 2015, 2:00 p.m. at the BAC Office, 2<sup>nd</sup> Floor, Provincial Capitol Bldg., Daet, Camarines Norte.

Bids must be delivered at Bids and Awards Committee Office, 2<sup>nd</sup> Floor Provincial Capitol Bldg., Daet, Camarines Norte on February 10, 2015 at 10:00a.m. to 1:30p.m. Opening of bids will be on February 10, 2015 at 2:00 p.m.

Bids will be opened in the presence of the bidder's representatives at the BAC Office. Late bids shall not be accepted.

The Provincial Government of Camarines Norte reserves the right to accept or reject any bid, to annul the bidding process and to reject any or all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder/s.
