Procurement will be conducted through open and competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Revised Implementing Rules and Regulations (RIRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act".

To bid for this contract, a bidder must be a Filipino citizens/sole proprietorships, partnerships, corporations, cooperatives or organizations with at least sixty percent (60%) interest or outstanding capital stocks belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

Bidders must submit of their statement of all on-going and completed government and private contracts including those awarded, but not yet started (whether similar or not similar in nature).

All bids must be accompanied by a Bid Securing Declaration and/or any of the acceptable forms and in the amount stated in ITB Clause 18.

Bids received in excess of the ABC shall be automatically rejected at bid opening.
