**Invitation to Bid for the Construction of Access Road (Phase I),  
Brgy. Mangcayo, Vinzons, Camarines Norte**

1. The *Provincial Government of Camarines Norte*, through the *LDRRMF – Special Trust Fund* intends to apply the sum of *Two Million Nine Hundred Ninety Seven Thousand Twenty Eight Pesos (P2,997,028.00)* being the Approved Budget for the Contract (ABC) to payments under the contract for the *Construction of Access Road (Phase I), Brgy. Mangcayo, Vinzons, Camarines Norte*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Provincial Government of Camarines Norte* now invites bids for *Const. of 3.00m width x 338.00lm x 0.15m thk. Road; with 0.50m shoulders and construction of 233.22cum riprap & grouted riprap on the right side only (Beg. @ STA 0+000)*. Completion of the Works is required *90CD*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”  
  
Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from the *Provincial Government of Camarines Norte* and inspect the Bidding Documents at the address given below from *8:00a.m. to 5:00p.m.*
5. A complete set of Bidding Documents may be acquired by interested bidders on *November 7 - 27, 2018* at the *Bids and Awards Committee Office, 2<sup>nd</sup> Floor, Provincial Capitol Building, Daet, Camarines Norte* and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of *Five Thousand Pesos (P5,000.00)*.  
  
It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS), provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
6. The *Provincial Government of Camarines Norte* will hold a Pre-Bid Conference on *November 15, 2018, 2:00p.m.* at *Bids and Awards Committee Office, 2<sup>nd</sup> Floor, Provincial Capitol Building, Daet, Camarines Norte*, which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat at the address below on or before **November 27, 2018 at 1:30p.m.** All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18.**

Bid opening shall be on **November 27, 2018, 2:00p.m.** at **Bids and Awards Committee Office, 2<sup>nd</sup> Floor, Provincial Capitol Building, Daet, Camarines Norte.** Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The **Provincial Government of Camarines Norte** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
