Description

Invitation to Bid for PR No. 18102383 – Supply, Delivery and Installation of Medical Equipment includes One(1) package 4000 GPD Reverse Osmosis Machine; One (1) unit 5 and 2 Station Semi-Automated Reprocessing Machine; One (1) unit Bicarbonate Powder Mixer and One (1) unit 100 slots Dialyzer Rack

1. The Provincial Government of Camarines Norte, through the Capital Outlay intends to apply the sum of Two Million Seven Hundred Forty-four Thousand Pesos (P2,744,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for PR No. 18102383 – Supply, Delivery and Installation of Medical Equipment includes One(1) package 4000 GPD Reverse Osmosis Machine; One (1) unit 5 and 2 Station Semi-Automated Reprocessing Machine; One (1) unit Bicarbonate Powder Mixer and One (1) unit 100 slots Dialyzer Rack. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The Provincial Government of Camarines Norte now invites bids for Supply, Delivery and Installation of Medical Equipment includes One(1) package 4000 GPD Reverse Osmosis Machine; One (1) unit 5 and 2 Station Semi-Automated Reprocessing Machine; One (1) unit Bicarbonate Powder Mixer and One (1) unit 100 slots Dialyzer Rack.

Delivery of the Goods is required upon receipt of Purchase Order/Notice to Proceed. Bidders should have completed, within 5 years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from the Provincial Government of Camarines Norte and inspect the Bidding Documents at the address given below from 8:00a.m. to 5:00p.m.

5. A complete set of Bidding Documents may be acquired by interested bidders November 13 – December 6, 2018 at the Bids and Awards Committee Office, Provincial Capitol Building, Daet, Camarines Norte and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (P5,000.00).

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS), provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The Provincial Government of Camarines Norte will hold a Pre-Bid Conference on November 22, 2018, 2:00p.m. at Bids and Awards Committee Office, 2nd Floor, Provincial Capitol Building, Daet, Camarines Norte, which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat at the address below on or before December 6, 2018 at 1:30p.m. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on December 6, 2018, 2:00p.m. at the Bids and Awards Committee Office, 2nd Floor, Provincial Capitol Building, Daet, Camarines Norte. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The Provincial Government Camarines Norte reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
